Commissioner Zinga echoed comments that the event was very nice. There was a lot of people and very well run.

Commissioner White also commented very nice event other than the train. He agrees with Commissioner O'Connell that there should be a police present due to the size of the event.

President Vonesh also commented great event. Good day and well organized. He thanked staff.

## **Staff Reports:**

Director

Director LoCascio shared that we were First Amendment Audited. We had everything ready and everything prepared. He commented how we were prepared.

Director LoCascio attended a PDRMA Legal Webinar and Fair Standards Labor Act was discussed being changed January 1. We have identified four employees that it would effect. Staff will meet tomorrow to discuss and staff will report to the Board at the November Board Meeting.

Director LoCascio discussed potentially doing an ADA Audit of our facilities and parks. Anything that is identified would help future plans. The Board approved getting a proposal.

## Superintendent of Parks

Superintendent Wick reported that four of our seasonal employees did not have school last two days so they helped split wood, cleaned up that area and restocked the Ice Arena wood supply for the start of the season. They also blew out the stone in the Ice Arena park lot and added stone chip.

Parks staff has been busy wrapping up projects. Still needing to be completed are re-landscaping the gazebo at North Park, new fascia boards on the Sunflower Nature Center and changing the lights on the over hangs to LED bulbs.

Leyden Make-a-Difference Day will be out on Saturday cleaning and mulching North Park.

Archery Program started Saturday with eight participants; the kids seem to have a lot of fun.

#### Marketing & Communication Manager

Manager Saponieri presented the Placer.ai software to the Board and the tracking of our facilities, parks and special events.

Manager Saponieri is working on expanding the Sponsorship Package for 2025 and adding new events.

The Susan G. Komen Event had a great turnout and we doubled the amount that we raised from last year.

# Superintendent of Finance/Technology

Superintendent Bersani discussed how each Fund's revenue & expenditures are proportionate to budget, with the exception of Recreation & Pool exceeding budget due to programming being intensive in the summer.

She is trying to finalize the audit in a timely fashion and keeping up with miscellaneous IT tasks.

Superintendent of Recreation

Superintendent Visteen reported that the Parade and Pumpkin Fest went well. The Leyden League Volleyball League is up and running with their first game coming up.

Ice Arena Manager

Manager Deak reported the Fusion, Starr Blades, Boys Club and Panther Hockey families will be participating in Trick or Treat at the Park this Saturday, followed by our annual Scary Skate from 2:00-3:30 p.m.

We are hosting 22 games of the CCM World Invite Tournament next weekend. Games are from 7:15 a.m.-9:30 p.m. Friday and Saturday, with two additional games on Sunday. We hope to see a successful weekend of concession and vending sales.

Manager Deak acknowledged how grateful she is to her part-time staff for their help in covering shifts, ordering supplies and keeping the front desk and concession operations running smoothly since Jasmine's departure.
